**AMENDMENT NO. 1**  
**TO THE BYLAWS OF**  
**GLENWOOD SPRINGS HOMEOWNERS ASSOCIATION, INC.**

This is an Amendment to the Bylaws made on or as of the 10th day of April 2018, by Glenwood Homeowners Association, Inc. (“Association”) as recorded in the Volusia County Public Records, Official Record Book 5684, Pages 3868 – 3878 (“Bylaws”), which amendments are in the numbered paragraphs below:

WHEREAS the Bylaws provide the Association with the right to amend the Bylaws upon approval by a majority of a quorum voting in favor of the amendment at a regular or special meeting of the Members.

WHEREAS the Association desires to amend the Bylaws

NOW THEREFORE, in consideration of the foregoing, the Bylaws are hereby amended as follows: (Old language is ~~stricken~~, new language underlined.)

**ARTICLE III- MEETING OF MEMBERS**

**Section 1. Annual Meetings. ~~The first Annual Meeting of the Members shall be held within one (1) year from the date of the incorporation of the Association, and each subsequent regular Annual Meeting of the Members shall be held on the same day of the same month of each year thereafter, at the hour of 7:00 o'clock PM. If the date of the Annual Meeting of the Members is a Saturday, Sunday, or legal holiday, the meeting will be held on the same hour of the first day following which is not a Saturday, Sunday or legal holiday. The~~ Annual Members' Meeting shall be held at such a place in Volusia County as is designated by the Board of Directors, on such day and hour in November of each calendar year as the Board of Directors shall designate, for the purpose of electing directors and transacting any other business authorized to be transacted by the members. Notice of the meeting shall be provided in accordance with Article III Section 3 entitled “Notice of Meeting.”**

**ARTICLE VI- BOARD OF DIRECTORS**

**Section 2. Regular Meetings: ~~Regular meetings of the Board of Directors shall be held bi-monthly~~ quarterly without notice at such place and hour as may be fixed from time to time by ~~resolution of the Board of Directors. Should said meeting fall upon a Saturday, Sunday, or legal holiday, the meeting shall be held at the same time on the next day which is not a Saturday, Sunday or legal holiday.~~**

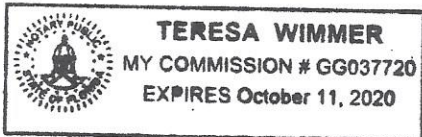
